

Wash and care instructions

These wash and care instructions are for mechanical gloves and forearm protectors of the following product families:

Cut protection:

uvex C500 series uvex C300 series uvex unidur series

uvex protector series

Simple mechanical protection:

uvex rubipor series: ergo and XS ergo and XG uvex profi series:

uvex contact series uvex phynomic series

uvex unipur series: 6630, 6631, 6634, MD, carbon

First-time use:

Gloves must be checked thoroughly before first use. It must be ensured that the gloves have no damages (e. g. incisions, holes). Faulty or damaged must not be used.

Cleaning:

Whether and how often a glove is allowed to be cleaned, heavily depends on the abrasion and the wearing rate of the glove. Gloves with heavy abrasion or damages have to be disposed of.

One or more cleaning cycles could take place, if a proper condition of the glove is

Do not use any chemicals or sharp-edged objects for cleaning the gloves (wire brushes, abrasive paper).
